Greetings to all of you. As all of you are aware that ONGC vide its order dated 7.2.2011 has unilaterally modified the Special Facilities for North East. Thousands of appeals were received by ASTO as well as ONGC. Keeping the sentiments of the officers at large in view we had represented to the management vide our letter dated 17.02.2011. However, we got no response from the management. Since we were not getting any response from the management, ASTO were forced to approach the Hon'ble High Court of Guwahati. The case came up for hearing on 25<sup>th</sup> February, 2011 and the Hon'ble Judge was pleased to pass the following order:
