The Central Working Committee of the Association of Scientific & Technical Officers, ONGC met on the 9<sup>th</sup> May 2007 at Kolkata and considered your conduct and behaviour. The CWC considered your reply dated 3<sup>rd</sup> May 2007 to the show cause notice no. GS/2005-2007/DA dated 11<sup>th</sup> April 2007 and reminder no. GS/2005-07/DA dated 27<sup>th</sup> April 2007 and after discussion on the issue in detail, expressed that your conduct is not only selfish and malicious but prejudicial to the interest of officers' community and that your reply was not satisfactory. After considering the facts and your conduct, the CWC unanimously resolved as under:

*The Central Working Committee after deliberating at length on the acts of gross misconduct and blatant violation of ASTO constitution committed by Shri. L.K.Mirchandani President ASTO Jorhat and his reply thereof, unanimously resolved that he has failed to explain his acts satisfactorily. Keeping in view the larger interests of officers' community, ASTO CWC unanimously resolves to expel Shri. L.K.Mirchandani Dy. Manager(MM) and President - ASTO Jorhat, from the Primary membership of ASTO for six years w.e.f. the date of issue of Notification by General Secretary CWC, as per the clause 11 of the Constitution and Bye Laws of the Association. Accordingly Sh.L.K.Mirchandani will cease to be the President, ASTO-Jorhat.*

In pursuance to the resolution of the Central Working Committee of the Association, it is hereby communicated to you that you stand expelled from the primary membership of ASTO for six years with immediate effect i.e. from the 9<sup>th</sup> May 2007.

In view of the above decision of ASTO-CWC, Sh.A.S.Nipun, Vice President, ASTO-Jorhat will discharge the duties of President, ASTO-Jorhat in addition to his own.
