## RESOLUTION

The constituents of Oil Sector Officers' Association, met at Delhi on 18.07.2006 and deliberated on the developments in the wake of the outcome of the legal proceedings held in the Hon. High Court of Delhi on 17<sup>th</sup> July 2006. The Hon. High Court of Delhi has disposed off the matter and directed the defendants (ASTO, ONGC) to take up the issue with the appropriate authorities.

Earlier, Ministry of Petroleum & Natural Gas vide their letter D.O No : G-35014/10-06-Fin III dated 21.02.2006 had requested the Secretary, DPE to consider the demands of the OSOA such as Pay Revision after 5 years w.e.f 1.1.2002, DA neutralization w.e.f 1.1.1996 instead of 1.1.1997 and 50% DA merger with Basic Pay in addition to providing stagnation reliefs.

MOP & NG had taken up the issue of DA neutralization, release of additional stagnation increments with the DPE under the contention that the DPE is the appropriate authority to decide these issues. However, the Secretary DPE in his letter dated 7<sup>th</sup> July 2006 addressed to Prime Minister's Office, the copy of which has been submitted in the Hon. High Court of Delhi on 17<sup>th</sup> July 2006, had clearly mentioned that the Navratna Boards are empowered to decide on the above issues and compensate its employees adequately.

In view of the above submission by the DPE the onus of settling the issues internally rest with the MOP & NG and the Managements of the Oil PSUs.

To take up the issue further, OSOA constituents unanimously resolved to continue with pressing for their legitimate demands and intensify the agitation in the following manner with MOP & NG.
